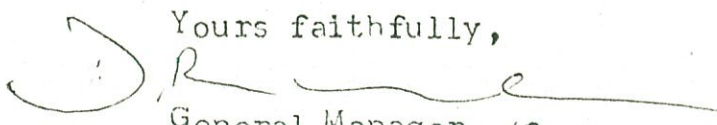

Hyderabad - request to vacate the

The Indl. Promotion Officer of this office who
visited plot No. 26/2, in Indl. area, Azamabad, Hyd. on
10.5.94 has reported that you are shifting your machinery
and equipment to Plot No. 26/2, indl. area, Azamabad, Hyd.
which was originally allotted to M/s. Vishwajit Castings
and which was lying vacant without any industrial activity
since more than 3 years. You may not be aware that
M/s. Vishwajit castings are served with a notice on 19.3.94
to submit the application for grant of fresh lease under
the new terms and conditions notified after the Azamabad
Indl. area act 15 of 1992 came into force w.e.f. 11-7-1992.
Instead of filing the application for fresh lease,
M/s. Vishwajit castings have filed a Writ Petition No. 7074/94
at the High Court of A.P. challenging the Act, stated above.
Your entry into the Plot No. 26/2 of Indl. area, Azamabad, Hyd.
is illegal and unauthorised as M/s. Vishwajit Castings is no
more a Lessee of Indl. area, Azamabad as all leases granted
earlier in Indl. area, Azamabad stand cancelled by 11.7.92. i.e.
the day on which Azamabad Indl. area act came into force and as
such any agreement between you and M/s. Vishwajit Castings to
set up your industry in the above said premises is not valid.

You are, therefore, directed to vacate the premises
immediately or else I have no other go to evict you forcibly
by observing normal procedure in vogue.
