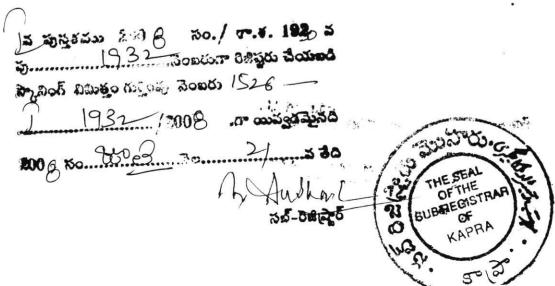

- B. Originally, the Schedule Land belonged to a partnership firm M/s. 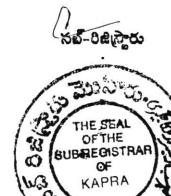

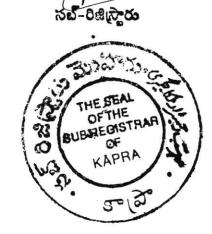
- iii) That the Purchaser shall become a member of the Mayflower Park Owners Association that has been formed by the Owners of the apartments in MAYFLOWER PARK constructed on the Schedule Land.
