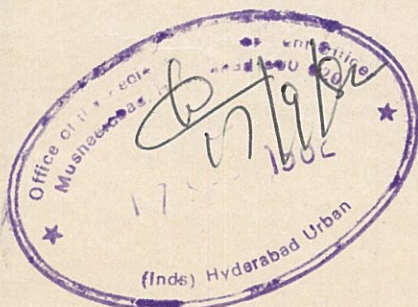

We had already submitted the copy of the plans submitted by us to Municipal Corporation. The plans were submitted by the undersigned as G.P.A. of the previous Lessee Shri Iaxmilal Pitti as also on behalf of the four sister concern in whose name the lease new stands transferred. We are once again enclosing the copy of the same. Our sister concerns and us had together paid a sum of Rs. 45,625/- on 29.7.1981 towards building permit fees. (Xerox Copy enclosed) vide MCH file No. 1054/7/1/81 and receipt 560/75 dt. 29.7.81. Till today we have not received the sanction and we had filled a writ petition in the A.P. High Court for reduction in the drainage fees of Rs. 67,525/- which was demanded in addition to building permit fees of Rs. 45,625/-. The court has granted the relief prayed for and directed the corporation to accept half the amount of building permit fees and drainage charges. The Municipal Corporation did not comply with the court order and we have secured the direction from the high court against municipal corporation. We request the industries department to approve our proposals and help us in setting up the unit at the earliest and oblige.

We trust you will find the plans and copy of the acknowledgement of building permit fees in ourder. We look forward to the approval of our constructions proposals. We are put to heavy losses due to the delays in getting required clearances. We once again hope that the Industries department will help us in starting the industry at the earliest.
