Sub: Industrial Area, Azamabad – Enhancement of premium
and monthly rental – Implementation -- Regarding

Government have decided to enhance the premium and monthly rental in the case of all plots hereafter in the industrial area, Azamabad, allotted on lease basis to lessees, with the following terms and conditions:

- (1) The Lessees shall pay a premium of Rs. 10,000/- (Rupees Ten thousands only) per acre, in all cases, instead of existing Rs.7,500/-.
 - (2) The monthly rental shall be 25 paise per square yard subject to escalation of 5 paise at the end of every three years.
2. The Commissioner of Industries is requested to take immediate necessary action to implement and apply the above two conditions, with immediate effect, to all plots in the Industrial area, Azamabad, hereafter and report the action taken.
 3. The Commissioner of Industries is further requested to acknowledge receipt of the memo.
