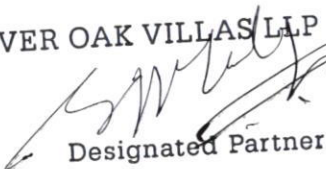


Plan of land being sold by the Vendor to the Purchaser
