DETAILS OF PERMITS: 2.

The Vendor has obtained permission from GHMC in file no. 3915/18/01/2013/ HO vide permit no 2.1 31305/HO/EZ/Cir-1/2014 dated 29.01.2014 for developing the Scheduled Land into a residential complex of 370 flats, consisting of two basements, ground and nine upper floors along with common amenities like roads, drainage, electric power connection, clubhouse, landscaped areas, etc.

PROPOSED DEVELOPMENT: 3.

- 7.2 Hereafter, the Purchaser shall be responsible for any loss, theft, breakage, damages, trespass and the like and the Purchaser shall also be obliged to pay monthly maintenance charges to the Vendor or the respective society or Association. The Vendor /Association shall be entitled to recover such dues, if any, from the Purchaser.

8.7 The Vendor shall be entitled to form the Owners Association and draft its bye-laws as he deems fit and proper. The Vendor and its nominees shall be the founding members of the Association. The Association shall be handed over to the members of the Association (i.e., prospective executive committee members. NOC FOR SURROUNDING DEVELOPMENT:

- 10.1 The Vendor proposes to develop other lands in the vicinity of the Scheduled Land in phases. 




Plan of the Scheduled Flat:
