**ORDER:-**

Whereas, every owner or occupier of agricultural land in the State shall have to put the land to non-agricultural purpose with the prior permission of the competent authority and on payment of conversion fee as per the provisions of Andhra Pradesh Agricultural Land (Conversion to Non-Agricultural Purposes) Act, 2006.

2. And whereas, the provisions of the Act do not apply to certain lands as specified under Section 7 of the Act including the land used for such other purposes as may be notified by the Government from time to time;

3. And whereas, the Government have decided to notify the land allotted to the Telangana State Industrial Infrastructure Corporation under section 7 of the Act so as not to cover the said land under the provisions of the Act;

4. The following Notification will be issued in the Extraordinary issue of Telangana State Gazette, Dated: 23-07-2015.

**NOTIFICATION**

The State Government of Telangana, under section 7 (e) of the Andhra Pradesh Agricultural Land (Conversion to Non-Agricultural Purposes) Act, 2006, notifies the Government Land allotted to the Telangana State Industrial Infrastructure Corporation for industrial purposes, for bringing the said land under the purview of section 7 of the Act, so as not to apply the provisions of the said Act to the said land.

2. The Chief Commissioner of Land Administration, Telangana State, Hyderabad and the Vice Chairman & Managing Director, TSIIC, Hyderabad shall take necessary action accordingly.
