## ORDER:

Whereas, the Government have issued policy guidelines in the G.Os 1<sup>st</sup> to 4<sup>th</sup> read above for allotting the excess land to such 3<sup>rd</sup> parties and declarants who were in occupation of such lands to minimize the litigation and ensuring speedy settlement of cases subject to certain conditions;

- 2. And whereas, several applications submitted under the said G.Os 1<sup>st</sup> to 4<sup>th</sup> read above are pending at various levels for examination and issue appropriate orders thereon;
- 3. And whereas, in the G.Os 5<sup>th</sup> and 6<sup>th</sup> read above, Government have issued policy guidelines for assignment and regularization and transfer of rights on lands encroachments on unobjectionable Government land and surplus land under Urban Land Ceiling. Pursuant thereto, fresh applications received for regularization of possession in Government land including surplus land under Urban Land Ceiling have to be disposed off as per the orders issued therein;
- 4. Therefore, in view of the policy decision taken by the Government in the G.Os 5<sup>th</sup> and 6<sup>th</sup> read above, Government hereby direct that;
  - (i) all the applications received under the G.Os 1<sup>st</sup> to 4<sup>th</sup> read above and pending at various levels would be examined and disposed off as per the guidelines issued therein; and
  - (ii) the applications filed in pursuance of the new policy would be examined and disposed off as per the orders issued in the G.Os 5<sup>th</sup> and 6<sup>th</sup> read above.
- 5. The Special Chief Secretary and Chief Commissioner of Land Administration, Telangana, Hyderabad / Special Officer and Competent Authority, Urban Land Ceiling, Hyderabad and Warangal shall take necessary further action in the matter accordingly.
