In G.O.Ms.No.50, MA & UD (Plg.II) Department, Dated: 22.04.2019, Government have amended certain provisions of Building Rules 2012. In pursuance of the same, the builders / developers associations have represented to the Government that some of the amended provisions are not conducive to real estate sector and requested to re-consider the same to promote investment in Real Estate Sector in the State of Telangana.

Government after careful examination of the matter hereby issue the following amendment to the Building Rules thereby modifying the same in G.O.Ms No.50, MA&UD (Plg.II) Department, Dated: 22.04.2019 read with G.O.Ms.No.168, MA, Dated.07.04.2012, G.O.Ms.No.245, MA, Dated: 30.06.2012 and G.O.Ms.No.7 MA, Dated 05.01.2016.

The foot note under the Table IV of sub-rule (a) (x) in G.O.Ms.No.50 MA&UD Department, Dated: 22.04.2019 which stipulates that "If the length or depth of the building exceeds 40 m, add to Col (4) ten percent of length or depth of building minus 4.0 m subject to maximum requirement of 20 m" is deleted.
