NOTIFICATION

In exercise of the powers conferred by Clause (s) of Subsection (2) of Section 326 read with Section 185 of Andhra Pradesh Municipalities Act, 1965 (Act 6 of 1965), the Governor of Andhra Pradesh hereby make the following amendment relating to the approval of layouts

AMENDMENT

In said rules of GO reference read above, the following provision shall be substituted in place of Rule 9(1).

- "A plot intended for residential purposes shall not be less than 120 square meters with a minimum width of 10 meters in all areas of the Town other than those set apart of -
- (a) Hut areas are declared as such under Section 205.
- (b) Slum clearance and rehabilitation areas as notified under the A.P. Slum Improvements (Acquisition of Lands) Act, 1956,
- (c) Areas to be developed by the Government or the Municipality or any other authority authorized by the Government or the concerned Municipality for housing SC,ST's, persons belonging to weaker sections of the society persons engaged in unclean occupation; and
- (d) Housing for industrial workers".
