- 2. The Metropolitan Commissioner, Hyderabad Metropolitan Development Authority, Hyderabad vide reference 3rd read above has informed that, an ORRGC Master Plan area has been notified as Special Development Zone in order to have planned Development in ORRGC. Special regulations, have been approved vide GO 4th and 5th read above. With regard to Social housing provisions in ORRGC area, the Metropolitan Commissioner, Hyderabad Metropolitan Development Authority, Hyderabad has recommended that, the provisions of Clause III and IV of Rules 11 of A.P Building Rules issued in G.O.Ms.No.245 MA Dated: 30.06.2012 may be made applicable on par with Greater Hyderabad Municipal Corporation, Hyderabad / Greater Visakhapatnam Municipal Corporation, Visakhapatnam / Vijayawada Municipal Corporation, Vijayawada.
- 3. In view of the above and after careful examination of the matter, the Government hereby issues the following amendment to the G.O. 2^{nd} read above.

AMENDMENT

In Rule 11 (iii) of A.P. Building Rules, 2012 issued vide GO $1^{\rm st}$ and $2^{\rm nd}$ read above, after the words, "In case of Greater Hyderabad Municipal Corporation, Hyderabad /", the following words shall be substituted:

"Hyderabad Outer Ring Road Growth Corridor in Hyderabad Metropolitan Development Authority, Hyderabad (1 KM belt on either side of ORR)/"

In rule 11 (viii) (a) of A.P. Building Rules, 2012 issued vide GO $1^{\rm st}$ and $2^{\rm nd}$ read above i.e., in the column under the item Area, after the words "Greater Hyderabad Municipal Corporation, Hyderabad", the following words shall be substituted:

"/Hyderabad Outer Ring Road Growth Corridor in Hyderabad Metropolitan Development Authority, Hyderabad (1 KM belt on either side of ORR)"
