1. Note on sale of Agricultural Land admeasuring 16.5 Guntas:

The firm in pursuance to its business of real estate developers had purchased various parcels of land at Cherlapally. In financial year 2005-06 a parcel of land admeasuring 16.5 Guntas was purchased. - 9. With the sale of this parcel of land, the firm could us lock its inventory holding and generate the funds to carry on its real estate projects. The sale has been beneficial to the firm in all the aspects and is out be business expediency and needs.
