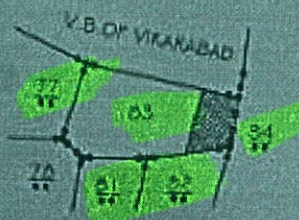


LOCATION SKETCH
