- 1. The I.T assessments for the Asst. Year 2016-17 is completed u/s 143(3) vide Order No. ITBA/AST/S/143(3)/2018-19/1014668155 dated 30-12-2018.
- 2. By virtue of the above Order, demand of Rs.44,95,911/- has arisen and for which Demand Notice u/s 156 No. ITBA/AST/S/156/2018-19/1014668173 dated 30-12-2018 has been issued.
- 3. While completing the assessment, addition of Rs.89,17,400/- has been made to the income returned of Rs.70,78,310/-
- 4. Aggrieved by the Asst. Order passed we have preferred an appeal before the First Appellate Authority CIT(A)-6. An appeal has been e-filed on 11-01-2019. The acknowledgement copy of the same is attached in **Annexure-1**. We are hopeful to get the relief as prayed for in the appeal.

- 7. In term of CBDT circular, it is requested to stay the collection of the balance tax till the disposal of the appeal by the First Appellate Authority.
