2. That the Donees hereby accepts the said gift of the said shares and all the rights, titles, interests and benefits, whatsoever, in respect thereof from the Donor, without any monetary consideration, of his free will and without any force or compulsion;
3. The Donor has hereby divested herself of the custody and ownership of the said shares and shall be free to instruct the company to transfer the said shares in the name of the Donees;

4. The Donor confirms, represents and assures that the said shares are free from all claims, liens, pledges, charges, prior gifts, bequests, inheritance claims, disputes, adverse titles or encumbrances of whatsoever nature;
5. That henceforth the Donees shall be exclusive lawful owner of the said shares and shall be entitled to receive all dividends, bonus shares, rights, entitlements and other benefits occurring thereon and shall be entitled to hold, deal with, transfer, alienate, encumber, gift, pledge, sell or dispose of the same, as the exclusive lawful owner thereof; and
6. The Donor shall sign and execute the requisite documents, agreements, deeds, undertakings and to do any other acts, deeds, things, which are necessary to give effect to this gift deed and to transfer the shares in the name of Donees.
