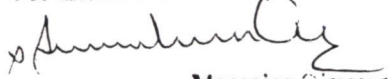

AND WHEREAS the parties hereto are desirous of modifying and altering the said Agreement of Loan in the manner hereinafter appearing.

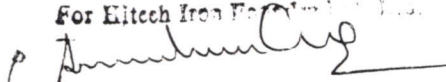
