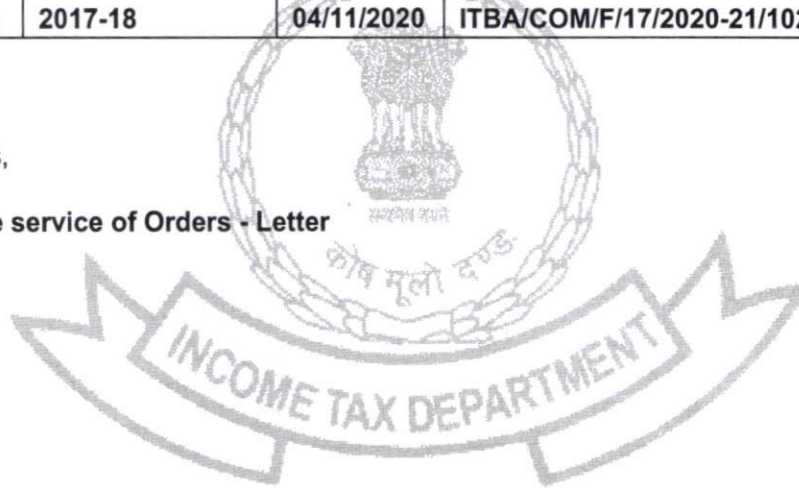

In case an appeal is pending relevant to the demand/demands above, intimate the details of appeal filed.

You may also be aware of Direct Taxes Vivad Se Vishwas Scheme,2020(DTVSV) which, if you are otherwise eligible, entitles to you the following benefits: withdrawal of all appeals against pending demand, immunity from levy of interest, penalty and institution of any proceeding for prosecution for any offence under the Income-tax Act in respect of matters which are covered in your declaration. Payment under the DTVSV,2020 is towards tax alone, and in case you are eligible and pay up the tax demand alone, you get relief towards demand of interest and penalty. Valid declaration under the Scheme also entitles you against institution of any prosecution proceedings in respect of the tax arrears.

You may also note that compliance dates under the Direct Tax Vivas Se Vishwas Act, 2020 falling during the period 20.03.2020 to 30.12.2020 have been extended to 31.12.2020.
