Sri.M.Jaya Prakash, Manager and Sri V.S.Sudhir, Authorized Representative, appeared for Personal Hearing and submitted a one page Synopsis of the issue. They submitted that they are contesting the computation of the Service Tax demanded in the show cause notice. For computation purpose, they have stated that the value of sale deed is also been taken into consideration. They contest that Service Tax is not liable on the value of sale deed. They have also reiterated the reply submitted vide letter dated 31.01.2014. They have drawn attention to the page no.42 of the reply dated 31.01.2014 and stated that they claimed to have paid Service Tax in excess. They requested a week time to furnish the written submissions on similar cases ordered by Commissioner (Appeals), Hyderabad and requested to keep the present show cause notice pending until disposal of the previous notices which has been remanded for denovo adjudication.
