In the course of hearing we have been requested to explain the observations and deficiencies stated by the Assessing Officer in Assessment Order u/s.143(3) dated 18-12-2018 for Assessment Year 2016-17 particularly with respect to the following:


1. Para 6 - Registration u/s.12AA of Assessment Order:

The AO has reproduced the para as contained in the letter of the The Commissioner of Income tax (Exemptions) vide order dated 27-08-2018 rejecting the our application dated 26-02-2018 seeking registration u/s.12A. The same is reproduced hereunder.

"Since the original trust deed/MOA and accounts have not been filed, it is not possible to verify the genuineness of the objects and activities of the assessee. Hence, the aims &Y objects of the Society could not be verified in absence of original MOA. As per Rule 17A, applicant has to file copy of Income & Expenditure account along with bills & vouchers. However, the assessee has not filed any documentary evidence like bills & vouchers and books of accounts for verification which is the requirement as per the Rule 17A, the genuineness of the activities could not be verified. Therefore, the genuineness of the objects and activity is in doubt."

In view of all the above fats, I am of the view that the applicant is not fit for grant of registration us/12AA of the Act. Hence, the

application in Form No.10A filed by the above applicant is here by rejected."

Due to certain reasons the hearing for seeking registration u/s.12A could not be attended to and therefore no submission and details could be furnished and consequently the application got rejected. The application filed in Form 10A on 26-02-2018 was required to be disposed off within a period of 6 months i.e., by 31-08-2018. Since the group accountant was pre-occupied with finalization of various IT returns to filed on or before 31-08-2018 and also with the tax audit works, could not attend to and furnished the required information. As the matter was getting time barred, the application got rejected. However in the course of the assessment proceedings the details of expenses, ledger account copies, income details etc. were furnished vide our letter dated 20-11-2018. Copy of the same is enclosed **Annexure 1**. It may be noted that the documents and information has been filed at the IT portal under e-proceedings.

It is therefore submitted that the Trust has been maintaining the books of account, vouchers, bills etc. as required under the Act. Thus there is no such deficiency. The Trust has been regularly filing ROI for past several years.

2. In para 8 of the Assessment Order the following is observed by the AO.

The assessee has filed a copy of an Trust Deed dt.16-11-1955 to claim that it is a valid trust. The trust deed has been perused and it an unsigned deed dated 16-11-2015. Even the witnesses have not signed the deed. In absence of original deed containing the signature of settler and witnesses this deed cannot be accepted as valid trust deed. The deed is also not registered. In absence of the signed deed it is doubtful that the assessee has taken valid registration u/s.12A.

As submitted the Trust has lost its Orginal Trust Deed dated 16-11-1955 and also the records of Trust Registration under I.T. Act.

In this regard we wish to submit and clarify that deed is a copy of the deed which is

The trust is registered with the Endowment Dept and we were in search of the Original of the Trust Deed. It appears that when we approached them, they have provided with us the True Copy of the Deed reproduced on the 'Copy Stamp' papers and therefore the deed do not contain the signatures but only the names of the settler and the witnesses.

3. In para 10 of the Assessment Order, the following is observed by the AO

As there is no registration u/s.12A and not carrying out charitable activities for which it was formed, the surplus of income over expenditure is brought to tax by denying exemption u/s.11.

We have already submitted the a note on the activities of the Trust along with payments of donations given towards activity of the Trust.

We hope you will find the above information in order and once again request you to grant the registration u/s.12A.
