In connection with the above the following is submitted for your kind consideration.

1. The I.T assessments for the Asst. Year 2016-17 is completed u/s 143(3) vide Order No. ITBA/AST/S/143(3)/2018-19/1014368412 dated 18-12-2018.
2. By virtue of the above Order, demand of Rs.10,60,129/- has arisen and for which Demand Notice u/s 156 No. ITBA/AST/S/156/2018-19/1014368456 dated 18-12-2018 has been issued.
3. While completing the assessment, addition of Rs.19,97,930/- has been made to the income returned of Rs.29,51,794/-
4. Aggrieved by the Asst. Order passed we have preferred an appeal before the First Appellate Authority CIT(A)-9. An appeal has been e-filed on 10-01-2019. The acknowledgement copy of the same is attached in **Annexure-1**. We are hopeful to get the relief as prayed for in the appeal.
5. Against the demand raised of Rs.10,60,129/- an amount of Rs.2,06,796/- is paid on 19-01-2019. The copy of the challan is attached in **Annexure-2**.
6. The amount paid is about 20% of the total demand raised.
7. In term of CBDT circular, it is requested to stay the collection of the balance tax till the disposal of the appeal by the First Appellate Authority.

We hope you will consider this stay petition favourably.
