We request you kindly to furnish us with copies of the following cited under reference of your notice.

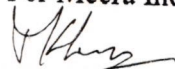

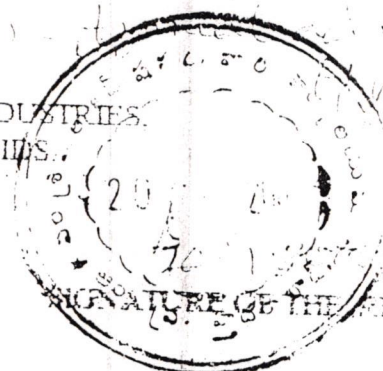
