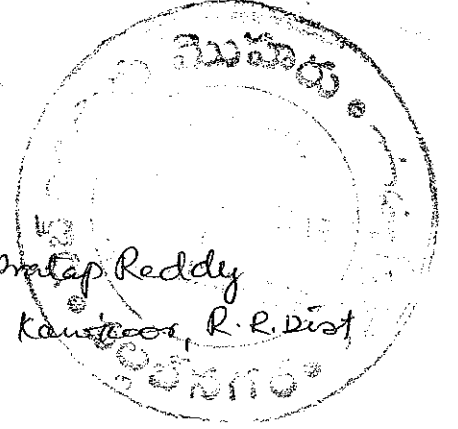

WITNESSETH:

WHEREAS, the Vendors and the Consenting Parties hereto have affirmed and assured that—

- (a) Mr. Mohammed Habeebulla was the original Pattadar of the land admeasuring Ac.9.38 Gts. in Survey No.196 of Kowkur Village, Malkajgiri Mandal, Ranga Reddy District, to which Mr. Sadula Ramaiah and Mr. Gowmarapu Jangaiah were the protected tenants;
- (b) Since Mr. Sadula Ramaiah was the protected tenant to the extent of Ac.5.00 Gts. and Mr. Gowmarapu Jangaiah was the protected tenant to the extent of Ac.4.38 Gts., in Survey No.196 of Kowkur Village, Mr. Sadula Ramaiah and Mr. Gowmarapu Jangaiah have separately obtained ownership certificates under Sections 35 and 37 of the Hyderabad Tenancy and Agricultural Lands Act 1950 and have been enjoying their respective lands in Survey No.196 of Kowkur Village in their own rights, title and interests;
- (c) In the family partition, the land admeasuring Ac.4.38 Gts. in Survey No.196 of Kowkur Village was equally distributed among Mr. Gowmarapu Jangaiah and his brother Mr. Gowmarapu Lakshma Reddy, in which each were allotted Ac.2.19 Gts.;
- (d) Upon the death of Mr. Gowmarapu Jangaiah, his land admeasuring Ac.2.19 Gts. in Survey No.196/60 of Kowkur Village had been inherited by the Vendors herein;
- (e) The name of the Vendor No.1 has been mutated in the revenue records and the Mutation Proceedings bearing No.Kowkur/ROR/12/89 dated 09.09.1991 were also issued by the Recording Authority cum UD Revenue Inspector, Kowkur, in pursuance of which the Mandal Revenue Officer, Malkajgiri Mandal, has issued the Pattadar Pass Book bearing No.274568 vide Patta No.142 in favour of the Vendor No.1 herein and the Revenue Divisional Officer, Chevella Division, has issued the Land Ownership Rights Deed (Title Deed) bearing No.212960 vide Patta No.142 in favour of the Vendor No.1 herein; and

- (f) In the compromise occurred in the Partition Suit in O.S.No.1141 of 2006 on the file of the learned IV Additional Senior Civil Judge, Ranga Reddy District, instituted by the children of the Vendor No.2 viz., Consenting Parties 4 and 6, the Vendor No.2 and the Consenting Parties 4 to 7 have got the share of 15 guntas out of the total land admeasuring Ac.2.19 Gts. in Survey No.196/Co of Kowkur Village, Malkajgiri Mandal, Ranga Reddy District, which is in the possession of the Vendor No.1 herein;

WHEREAS, the Vendors herein, along with the Consenting Parties, being in dire emergent need of money, have offered to sell to the Vendees, the land admeasuring Ac.2.00 Gts. out of their total land admeasuring Ac.2.19 Gts. in Survey No.196/Co of Kowkur Village, Malkajgiri Mandal, Ranga Reddy District, which is including the undivided share of 15 guntas belonging to the Vendor No.2 and the Consenting Parties 4 to 6 attained by virtue of the Compromise Decree in O.S.No.1141 of 2006, and the Vendees have accepted to purchase the same, due to their accounting adjustments, now obtaining this Sale Deed to purchase the land admeasuring Ac.0.23.91 Gts. in Survey No.196/Co of Kowkur Village, which is comprising the land admeasuring Ac.0.19.43 Gts. belonging to the Vendors 1, 3 and 4 and the land admeasuring Ac.0.04.48 Gts. belonging to the Vendor No.2 and the Consenting Parties 4 to 6, more particularly described in the Schedule hereunder, delineated in the Map annexed to this Deed and hereinafter referred to as the "Scheduled Land" for brevity, for the total and sufficient sale consideration of Rs.54,00,000/- (Rupees Fifty Four lacs Only), and the Vendees has accepted to purchase the Scheduled Land for said sale consideration and in furtherance thereof, the Vendors hereto have agreed to sell, convey, transfer, grant and assign the Scheduled Land together with all their rights, titles, interests, as possessed and enjoyed by them and the benefits, facilities, privileges, easements, advantages, etc., belonging to or in any way appurtenant thereto and the Vendees has agreed to purchase the Scheduled Land, for the aforesaid monetary consideration of this sale deed, and hence, the Vendors, the Consenting Parties and the Vendees, hereto, hereby execute this Sale deed.

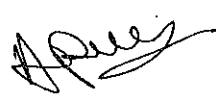
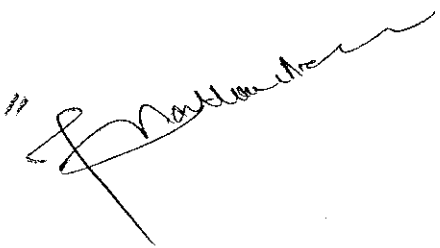

- N.B.:- 1) The payments made to the Vendor No.2 and the Consenting Parties 4 to 7 Herein are in consonance with the Lok Adalat Award dated 07.02.2011 in O.S.No.1141 of 2006 and thus, all the rights, title, interests, possession, etc., whatsoever, of the Vendor No.2 and the Consenting Parties 4 to 7 herein, in respect of the Scheduled Land particularly to the tune of Ac.0-04.48 guntas are also stood fully transferred and conveyed to the Vendees; and
- 2) The distribution of the sale consideration among the Vendors herein as above are only as per the affirmative instructions given by the Vendors and the Consenting Parties herein though they are irrespective of their respective shares and though no title or interests are passed in favour of the Consenting Parties herein upon the death of Mr. Gowmarapu Jangaiah, the father of the Vendors herein, who was allotted with the Scheduled Land in the family partition with his brother Mr. Gowmarapu Lakshma Reddy, the payments to the Consenting Parties 4 to 7 herein are made only to satisfy the terms of the Award in O.S.No.1141 of 2006.

That, the Vendors and the Consenting Parties hereto have declared and assured that the Vendors herein have been has been in exclusively peaceful and vacant possession of the Scheduled Land and that there have been no interruptions, interferences, injunctions, etc., in and against such possession in respect of the Scheduled Land and having such flawless possession and enjoyment over the Scheduled Land, the Vendors herein have today delivered the vacant and peaceful physical possession of the Scheduled Land to the Vendees and the Vendees having thus become the absolute owners and exclusive possessors of the Scheduled Land under this Deed shall be entitled to possess and enjoy the Scheduled Land as absolute owners and exclusive possessors from this day, without any obstruction, disturbance or hindrance from anybody including the Vendors, the Consenting Parties or anyone claiming through or under them.

3. That, the Vendors and the Consenting Parties hereto have declared and assured that the Scheduled Land is free from all encumbrances, mortgages, charges, litigations, prior agreements, joint family interests, any pledges, negative lien, positive lien, non-disposal undertakings, priority, hypothecations, assignments, attachments, claims, restrictions, arrears of municipal, revenue or other taxes and electricity and water service bills, lis pendens, acquisition or requisition proceedings for road widening, protected tenancy rights or such other tenancy disputes, etc., and set off or other security interests of any kind or any other sorts of agreements or arrangements having the effect of conferring security or charge upon or with respect to the Scheduled Land.
