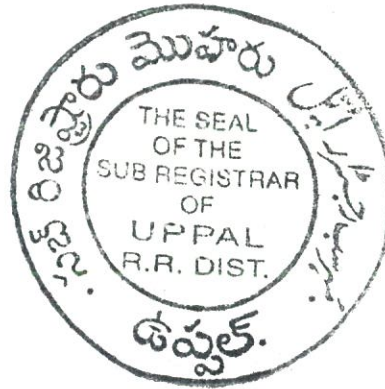


3.
