NOW KNOW WE ALL AND THESE PRESENTS WITNESSETH that I/We, do hereby unconditionally and irrevocably nominate, constitute and appoint ABFL (hereinafter referred to as the said "Attorneys") as my/our true for true and lawful attorney for me/us in our name and on my/our behalf and at my/our cost and risk to do, execute, and perform all or any of the following acts, deeds, matters, and things, that is to say:

- a) To collect the Title Documents of the Immovable Property/ies from the Existing Lender and to keep it in its custody for the purpose of creating a legal mortgage/an equitable mortgage by deposit of title deeds in favour of ABFL.
- b) To give a receipt/discharge to the Existing Lender on collecting the Title Documents of the Immovable Property/ies.
- c) To collect a No Dues Letter from the Existing Lender.
- d) To make, execute, sign, seal and deliver and cause to be registered in my/our favour at my/our cost and expense (inclusive of all stamp duties, fees and taxes) in all respects a Deed of Reconveyance of the Immovable Property/ies from the Existing Lender in my/our favour (in case of a Registered Mortgage Deed of the Immovable Property/ies executed and registered in favour of the Existing Lender by me/us).

- h) I/We do hereby agree that all or any of the powers hereby conferred upon the said Attorney (ABFL) may be exercised by any officer or any officers of the said Attorney in writing by ABFL/any other Constituted Attorney/Authorised Representative of ABFL specifically authorized by way of a POA/Letter in that behalf by ABFL.

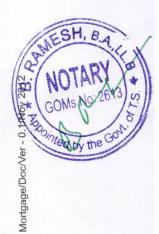
