Whether such an Agreement is executed or not, this acknowledgement itself shall oblige me/us to confirmed abide by the General Terms and Conditions of Supply notified by the Company from time to time.

VII. I/We certify that there is no case of Theft of Electricity/Unauthorized use of Electricity, pending against me.

VIII. I/We undertake that if the number of services in the same premises/compound is above four, I will apply for the panel board.
