Your site is located at a distance 27944 mts from ARP and lies in the grid XX56-1 of the published CCZM of Hyderabad airport. The Permitted top elevation for this grid is 675 mts.

Since the requested top elevation 648.75 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.
