NOTE :

1. The applicant should purchase, Meter fixed Empanelled Agency and hand over to GB agency a water meter conforming to ISO-4064, Class-B/AMR for releasing Connection.
2. Water Connection will be released only after constructing Meter Chamber of size 2.50m X 1.0m (minimum Size) with lock and key arrangement. The applicant has to safe guard the water meter from theft or any tampering.
3. Connection will be released only after constructing Meter Chamber and separate sump for potable water with dedicated potable water supply line and fixing of AMR Meter.
4. Connections sanctioned under Bulk Category, to conclude the agreement for quantity at O/o the CGM (Engg) Revenue, for releasing the physical water connection.
5. The additional length of connection from meter chamber to sump has to be taken up at the cost of the applicant.
6. Connection will be released only after, laying the proposed Mains of water supply and sewerage, for which the improvement charges are levied.
7. Construction of Rain Water Harvesting structures in the premises are mandatory and should be as per the design approved by HMWSSB.
8. Connection will be released after submission of occupancy certificate from GHMC. if not, will be released, duly charging 3 times as per Government Orders.
9. Silt chambers are mandatory for all commercial areas in the premises Category - III.
10. HMWSSB reserves the right, to revise this order at any time, if there is any variation in field particulars.
11. Obtaining the Sewerage connection is the responsibility of the applicant, duly consulting the HMWSSB & GHMC field officers. If road cutting permission is required for obtaining the sewerage connections, the applicant shall obtain the same from GHMC by paying requisite charges.
12. The connection given to the premises does not confer any legal right regarding the property in question.
13. HMWSSB reserves the Power to require owners of premises to set up pumps from sumps etc- Water Supply connection by the Board for any purpose including that of domestic use shall be given only at the ground level of the premises.
14. Wholesome water supply provided by HMWS&SB for drinking and culinary purposes shall not be liable to contamination from any less satisfactory water.
15. No pipe for the conveyance or in connection with water supplied by the Board shall communicate with any other receptacle used for conveyance other than water supply by the Board.
16. AMR Meter Charges collected by HMWSSB includes, the maintenance from date of installation for a period of 05 years and thereafter, the consumer is liable to pay towards meter cost and its maintenance.
17. The Applicant/Consumer has to adhere to all the provisions of the HMWS&SB Act No.15 of 1989 as amended by Act No.28 of 2007 with rules and regulations as amended from time to time.
