WITNESSETH:

WHEREAS the Lessor owns and possesses a land covered by Sy.No. 199/U, for an extent of Ac.0-24 gts., situated at Thimmapur village, Kothur Mandai & G.P., Mahabubnagar Dist, which is more fully described in the schedule property for carrying on his industrial activity where he proposes to install the machinery and equipment financed by the Andhra Pradesh State Financial Corporation against the security (first charge) in favour of APSFC.

- That the Lessee is hereby put in possession of the scheduled land from today, i.e. execution of this Lesse Deed.
- That this Lease Shall be for a period of 30 years, commencing from today i.e execution of this Lease Deed to be renewed at the option of the Lease for a further period of 5 years, by executing fresh Lease Deed.
- That it is hereby mutually agreed to between the parties that the Lessee shall
 pay the electricity and water charges leaving municipal and other property taxes
 to paid by the Lessor.
- That the Lessec hereby expressly permitted to the Lessor to mortgage his Lessee lease hold interest in favour of ANDHRA PRADESH STATE. I'NANCIAL CORPORATION, Chirag Ali Line, Hyderabad – 500 001, Andhra Pradesh.
- 6. That the Lessee hereby undertake to keep the schedule land in a good and habitable condition during the tenure of this lease and to allow the Lessor or her representative to inspect the schedule land at all reasonable times.
- 7. (a) That the Lessor undertakes to inform Andhra Pradesh State Financial Corporation in writing three months in advance in case Lessor is initiating any Action for eviction of Lessee in order to allow the Andhra Pradesh State Financial Corporation to safe guard its machinery and shift and shift to another premises.

(b) The lessor hereby agrees and undertakes that he will not obstruct or Prevent A.P.State Financial Corporation to enter into the lease hold premises and seize the machinery and take it away if necessary when the lessee commits any defaults in respect of the loan obtained / to be obtained from the said A.P.State Fianancial Corporation without recourse to the Lessor.

(c) The Lessor hereby undertakes that he will not exercise any right or lien over the assets financed by the corporation and will not claim the rental arrears

from the corporation.

(d) The Lessor further undertakes that he will proceed against only lessee for recovery of rental dues for any damages and will not made the APSFC as party for any suit in this connection.

8. That it is hereby agreed that the lessor shall attend to the annual repairs and

maintenance of the scheduled land.

9. That the Lessor hereby undertakes to pass on regular receipts for the rents paid by the Lessee.
