On application for registration filed through GSTN Portal by the Tax Payers online, the GST registration will be generated and allotted by the Portal and the jurisdiction of such registrant is depending on various factors like place of business, address of registered office, previous GST registration already obtained by applicant, additional place of business etc. In other words, such registrations need not necessarily fall under the jurisdiction of Miryalaguda where the Tax Payer undertaking Real Estate business. Further, some of the registrations will be allotted to the administrative control of State GST authorities by the GSTN Portal automatically. On verification, it is found that the Builders/Developers mentioned in your application found to be not under the administrive control of the Miryalaguda Central GST Range. However, on enquiry, it is found that two Builders listed in the table given in your application viz.
