In view of the above please provide me the following:

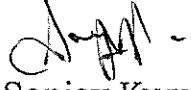

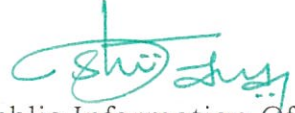
