Treatment of sewage to achieve the desired output can be done through various different technologies like anaerobic septic tank, membrane based STP, open aeration tanks, reefbed technology using plants for aerification, activated sludge plant, rotating disc systems, etc.

Despite several enquiries none of the authorities are able to provide specifications for the type of STP to be used or details of output from such STPs.

2. Copy of any order, notification, rule, etc., that specifies the desired output from such STP to be used for commercial complexes, housing complexes and layouts, for discharging the output from such STPs to the community nala or soak pits. like:
 - s. Standards for BOD
 - t. Standard for pH.
 - u. Standards for COD.
 - v. Standards for Nitrogen,
 - w. Standards for Phosphates,
 - x. Standards for TSS, etc.
3. Copy of any relevant order, notification, rule, etc., pertaining to sewage treatment to be used for commercial complexes, housing complexes and layouts.

Please provide me the above information at the earliest.
