5. Provide sketch or plan of proposed nala indicating the survey numbers through which the nala is passing and the portion of each survey number proposed to be acquired.
6. Provide details of compensation proposed to be paid for acquisition of the said lands.
7. Details of total length of canal proposed to be constructed. Provide details of starting point of canal and ending point of canal.
8. Provide section drawing of the proposed canal.
9. Several other gazette notifications would have been issued for acquisition of entire length of the proposed canal. Provide details of such notifications issued.

The above information is required us for reference. Therefore we request you to provide the details as per your records. We have deposited a requisite fee of Rs.10/- by way of Postal Order. kindly provide the above information and we are willing to pay the further charges if any.

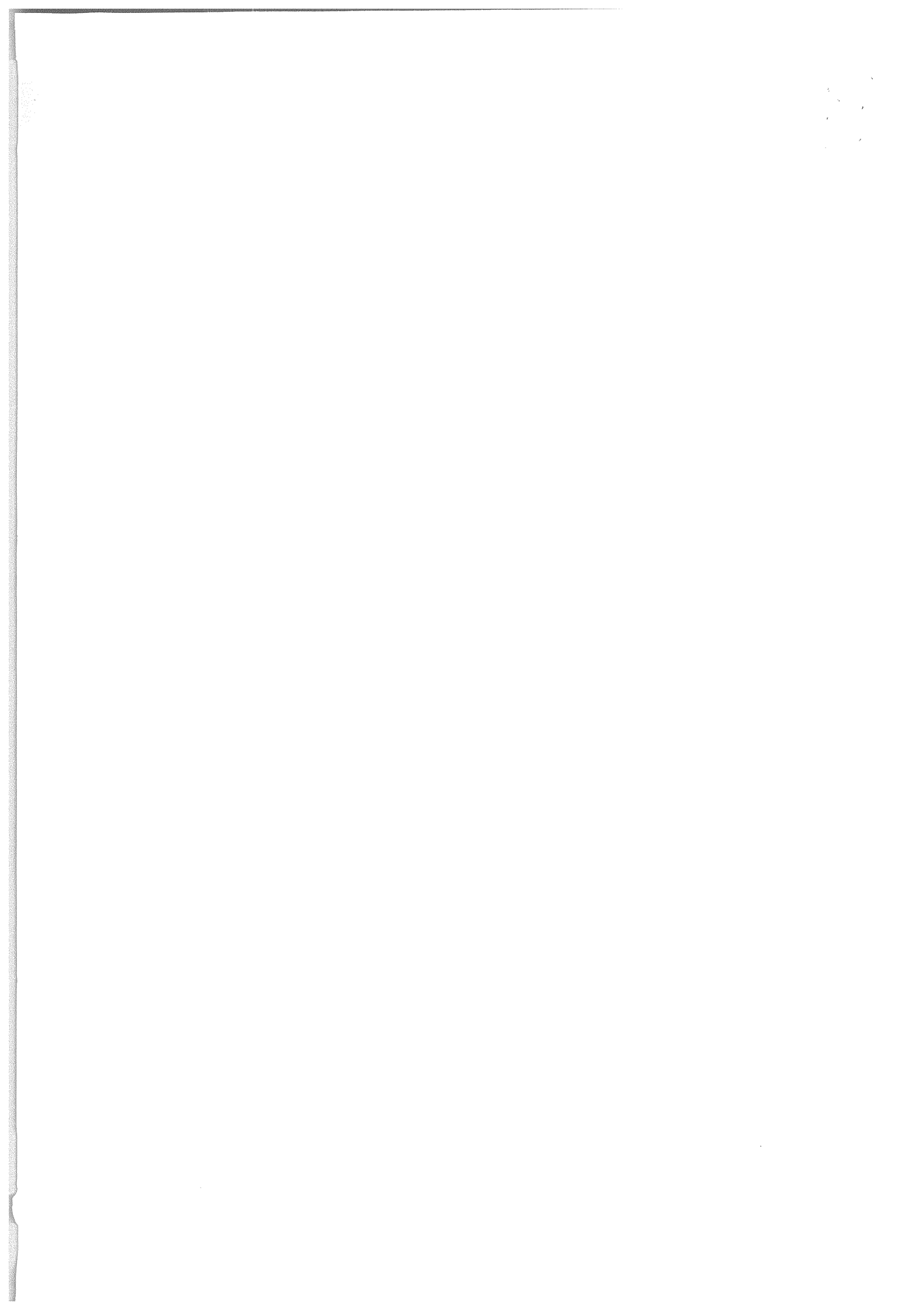
Through reference cited above, the Revenue Divisional Officer, Keesara Division has reported that the Preliminary Notification U/s 11 of the Act 21 of 2017 approved by the Collector, Medchal-Malkajgiri District lands proposed for Kondapochamma Sagar of Kaleshwaram Project of Thurkapally Canal on Jagadevpur Canal situated at Kolthur Village, Mudichintalapally Mandal, Medchal-Malkajgiri District was approved and published vide Gazette No. MMD.40, dated: 27.08.2019.

Further, on the request of RDO, Keesara Division, the appropriate Government/Collector, Medchal-Malkajgiri District has extended the time period for publication of Declaration till 26.08.2022 U/s 19(7) of the Act 30 of 2013.

Now, the RDO, Keesara Division has stated that no funds have been received from the requisition department towards acquisition of lands and according to the provisions as laid down U/s Act 30 of 2013, no Declaration shall be made unless the requisition body deposits an amount, in full or part towards the cost of acquisition of land and requested to extend the time period for Publication of Declaration for further period of (12) months w.e.f 27.08.2022, U/s 19(7) of the Act 30 of 2013 in respect of the above lands under acquisition.

The Executive Engineer, I&CAD, Division No.5, Gajwel during a meeting on 22.08.2022 has stated that the Turkapally Canal is part of Kaleshwaram Project, which irrigates an ayacat of 27100 Acres and provides water for industrial use in Siddipet, Yadadri Bhongir and Medchal-Malkajgiri Districts. The main canal work component has been completed. For the distributory system the land acquisition

process in upstream side i.e., in Siddipet District and Yadadri Bhuvanagiri District are delayed due to Covid-19 pandemic, but now are in advance stages. To provide an Ayacut of around 9600 Acres in Medchal- Malkajgiri Dist., it is indispensable to acquire the land for the distributors in Shamirpet and Muduchinthalapally Mandals or else huge capital expenditure incurred on the project will be unproductive and unfruitful. Hence, land acquisition process need to be completed at the earliest so that downstream canal works can be taken up shortly and requested to extend the time for publication of Declaration.

In view of the above facts and circumstances stated by the LAO & Executive Engineer, the time for publication of Declaration U/s 19 (1) of Act 30 of 2013 is extended for a further period of twelve months.

NOTIFICATION

In exercise of the powers conferred U/s 19 (7) of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act 30 of 2013 the time for publication of the Declaration U/s 19 (1) Act 30 of 2013 is hereby extended the period of twelve months from 27.08.2022 to 26.08.2023.
