The Court made the following: ORDER

THE HONOURABLE SMT JUSTICE P.MADHAVI DEVI W.P.No. 7087 of 2021

ORDER:

In this writ petition, petitioner is seeking a writ of mandamus declaring the orders passed in Case No.DPE/RRS/SD02/16946/20, dated 25.01.2021 by the respondent No.3, as illegal, arbitrary and consequently to set aside the same and to pass such other order or orders.

- 2. Learned counsel for the petitioner submitted that the respondents have issued a Provisional Assessment Order, dated 16.10.2020 and the petitioner has filed its objections to the same and thereafter, the final assessment order dated 25.01.2021 was passed. Challenging the same, the present writ petition is filed.
- 3. Initially this Court has taken note of the fact that the petitioner has already paid 50% of the assessed amount. Therefore the official respondents were directed not to take any coercive steps.
- 4. Learned counsel for the respondents have filed counter affidavit along with a vacate stay petition.

- 5. It is noticed that the petitioner has challenged the quantum o demand in the final assessment order and the same cannot be decided by this Court under Article 226 of Constitution of India. It is further noticed that the remedy lies with the respondent No.2 and the petitioner would have to approach the respondent No.2 for adjudication of the appeal.
- 5. Learned counsel for the petitioner submitted that the petitioner would approach the respondent No.2 with an appeal and the respondent No.2 may be directed to dispose of the appeal with n a time frame.
- 6. Having regard to the above submissions and particularly the fact that the petitioner has already paid 50% of the assessed amount as required to file an appeal before the respondent No.2, this Court deems it fit and proper to direct the petitioner to approach the respondent No.2 by filing an appeal within a period of thirty (30) days from the date of receipt of a copy of this order and thereafter, the respondent No.2 is directed to dispose of the said application within a period of three (3) months there from. Till such time, the appeal is disposed of, the respondents are directed not to take any coercive steps, such as

disconnection of power supply to the petitioner, unless there are any other dues.

7. Accordingly, this writ petition is disposed of. There shall be no order as to costs.

Miscellaneous petitions, if any, pending in this writ petition, shall stand closed.
