Occurred on 24-08-2023 at 08.20 A.M. between Mamandur- Kukkaladoddi villages, on Renigunta – Kodur main road, Renigunta Mandal and reported in the P.S. on the same day at 11.30 A.M. by the complainant Lagadapati Siva Rama Krishna, age 59 years, S/o Late L. Raghavulu, Door No.2-75, Ramalayam street, Raitunagar, Bansuwada mandal, Kamareddi district, Telangana state, where in the petitioner stated that his son L.Raghuram is working as a software engineer at Hyderabad. The complainant and his family members came to Tirupati to attend their relative's marriage. On 23-08-2023 at 09.00 PM, his L.Raghuram also left in his car bearing Reg.No. TS-16-EH-2673 to Tirupati on his official work. Today, i.e., 24/08/2023 at about 08.20 AM, his son drove his car in a rash and negligent manner, lost his control over his vehicle and dashed against road side tree, resulting which his son sustained severe injuries on his person. Later, the injured person shifted to Ruya Hospital, Tirupati for treatment. On receipt of phone call, the complainant and his relatives rushed to Ruya Hospital and came to know that the duty doctors examined his injured son and declared that as brought dead at 09.00 A.M. In this accident, the car also badly damaged. Subsequently, the complainant came to PS and gave a report.
