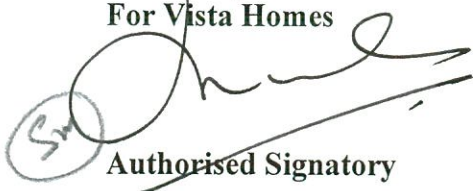

We sincerely regret the inconvenience caused in this regard. Kindly acknowledge the receipt of this letter and do the needful.

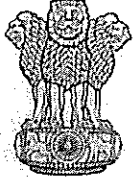
