There is no clarity about the setbacks to be maintained between blocks of flats and tot-lot that is falling in between blocks of flats in the case of Stilt + Five upper floors and in the case of High rise buildings/MSB.

GO No. 168 does not specify the distance to be maintained between the tot-lot and blocks of flats.

Please provide a copy of any GO, memo, rule, etc., that specifies the setback to be maintained between tot-lot and blocks of flats.
