As discussed the consultancy charges payable to you shall be as follows:

- 1. For projects at AMTZ, Vizag Rs. 4/- per sft of total constructed area which shall include office/lab space, support spaces like chemical stores, solvent stores, parking, services, electrical room, head room, etc. However, they shall exclude open to sky areas like terraces, etc.
- 2. For projects at Dilpreet Tubes at Nacharam Rs. 3/- per sft of total constructed area which shall include office/lab space, support spaces like chemical stores, solvent stores, parking, services, electrical room, head room, etc. However, they shall exclude open to sky areas like terraces, etc.
- 3. Payment terms 10% advance, 20% on completing drawings for permits (fire, building, PESO, CFE, CFO, environment clearance), 20% on obtaining building permit. Balance 50% in 5 quarterly instalments from building permit. First instalment shall be due 3 months from building permit.
- 4. Scope of work preparing concept drawings, basic elevations, plans for permits, liaisioning with consultants and clients, preparing drawings for corrections/alterations related to permits.
- 5. Exclusions cost of renderings.
- 6. Site visits within Hyderabad 10 nos per year without charge. Beyond that Rs. 5,000/- per visit. Site visits to Vizag Rs. 10,000/- per visit. Travel and accommodation to be paid extra.
- 7. GST as applicable. TDS shall be deducted.
- 8. Duration of consultancy 2 years from building permit. Extension of duration shall be @ 5% of total consultancy charges payable every quarter.
- 9. These rates shall be applicable for future projects, subject to increase from time to time.
