Annexure -2 - Instructions

Access Reporting Portal

Steps for accessing the Reporting portal are different based on the type of information sources. The same are as following:

For Deductors – TAN based information source

Login to the e-filing <https://eportal.incometax.gov.in> through your 'TAN' and navigate to 'Pending Actions' >> 'Reporting Portal' >> 'Others'. You will be re-directed to the Reporting Portal.

Note: If the user is not already registered through TAN, then registration must be completed first by clicking on the "Register" button available on e-filing portal and then providing relevant details. After successful registration, login step can be performed on the e-filing portal.

For PAN based information source

Login to the e-filing <https://eportal.incometax.gov.in> through your 'PAN' and navigate to 'Pending Actions' >> 'Reporting Portal' >> 'Others'. You will be re-directed to the Reporting Portal.

Note: If the user is not already registered through PAN, then registration must be completed first by clicking on the "Register" button available on e-filing portal and then providing relevant details. After successful registration, login step can be performed on the e-filing portal.

For Reporting Entity – ITDREIN based information source

Login to Reporting Portal <https://report.insight.gov.in> through PAN of authorized person (Designated Director (DD)/ Principal officer (PO)).

For Data Exchange Partners

Login to Reporting Portal <https://report.insight.gov.in> through PAN of authorized person.

Submit Response at Reporting Portal

Step 1 : Go to Requests tab

Step 2 : Click on the download icon given for each batch ID under **Download Batch XML** column. Upon clicking the icon, batch is downloaded in XML format.

Step 3 : After downloading, import the XML in Information request utility and fill in the relevant details as requested in the downloaded batch XML and generate secure package.

Step 4 : After generating the secured package, upload the same by clicking on 'Submit' hyperlink provided under 'Upload Batch Response Packet Column'.

Note: Functionality to submit online response (without Information Request utility) is also available for batch not having higher count of records. For the same, click on 'Submit' link available under 'Online Response' column and submit the response one by one for all the requests available in the batch.

Help documents (quick reference guide, user guide and FAQs) are also provided in the "Resources" tab on Reporting Portal for further assistance. You can refer the same for any queries related to Reporting Portal or submission of response. You can also seek assistance by email/callback option in the 'Help' section.
