Brokerage shall be paid for customers introduced by you only if the sale is closed within 3 months from date of introduction of the prospective customer.

Customers who have contacted us prior to intimation by you as given above, shall be deemed to be customers of Modi Properties and brokerage for such customers shall not be payable. The final decision in this matter shall be at the discretion of Modi Properties and claims shall not be made on this count.

8. A sum of Rs. 10,000/- shall be paid to you, within 7 days of the customer signing the agreement of sale. The balance brokerage shall be paid to you (after deducting TDS + GST), within 15 days of receiving 40% of total sale consideration from the customer for their flat /villa.

11. You may contact the respective sale managers for any further information or arranging a site visit.

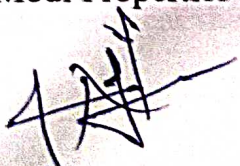
12. Support by way of brochures, flyers, arrangement for site visits, etc., shall be provided by Modi Properties free of cost.

13. Modi Properties shall have right to terminate this agreement at any time without assigning any reason at its discretion.

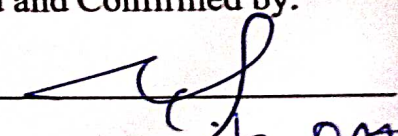

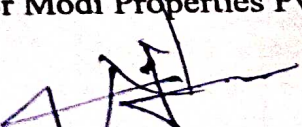
