4. Our sales team will handle the customer after your introduction of the customer to our sales team.



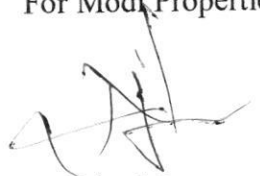

5. For all customers introduced by you brokerage at the rate of 2% on the net sale consideration shall be paid to you. 6. Brokerage shall be paid for customers introduced by you only if the sale is closed within 3 months from date of introduction of the prospective customer.
7. Customers who have contacted us prior to intimation by you as given above, shall be deemed to be customers of Modi Properties and brokerage for such customers shall not be payable. The final decision in this matter shall be at the discretion of Modi Properties and claims shall not be made on this count.
8. A sum of Rs. 10,000/- shall be paid to you, within 7 days of the customer signing the agreement of sale. The balance brokerage shall be paid to you (after deducting TDS + GST), within 15 days of receiving 40% of total sale consideration from the customer for their flat /villa.

13. Modi Properties shall have right to terminate this agreement at any time without assigning any reason at its discretion.

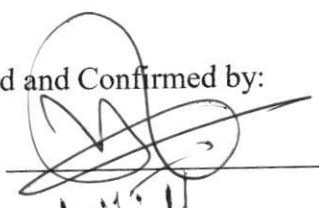

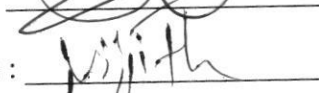
