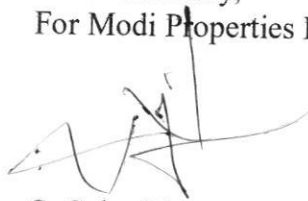
1. You shall be permitted to promote the said projects amongst your customers, business associates, etc.

5. For all customers introduced by you brokerage at the rate of 2% on the net sale consideration shall be paid to you.
