favour of landowners

Minutes of meeting between Preethi, Soham Modi, Jagadish on 30.05.2020.

- 1. The issue of raising bills in favour of landowners by the developer was discussed. Landowners already receiving installments from purchasers and are liable to pay GST on the installments received.
- 2. This note is for the projects Gulmohar Residency and Mayflower Platinum which are been monitored by Preethi/Pranav/Ajay Mehta on behalf of landowners and developer.
- 3. It is agreed that the bills raised by developer on the owners was by and large exceed the bills that the owners have to raise in favour of their prospective customers. In both the projects the developer is raising invoices in favour of the owners irrespective of whether they are sold or unsold.
- 4. It was agreed that in both the projects the landowners will raise GST bills in favour of prospective customers based on milestones mentioned in their respective AOS.
- 5. Wrt GMR the following polices shall be adopted:
 - a. First sale rate by builder closest to JDA adopted rate Rs. 3,850/- per sft for 1,660 sft flats and Rs. 3,985/- per sft for 1,360 sft flats.
 - b. Developers to raise bills in 5 parts in favour of owner as follows:
 - i. 20% on Plinth Beam
 - ii. 25% on RCC slab
 - iii. 25% on Brick work & plastering work
 - iv. 20% Finishing works
 - v. 10% on Completion
- 6. Wrt MPL the following polices shall be adopted:
 - a. First so rate by builder closest to JDA adopted rate Rs. 3,882/- per sft for deluxe flats. For luxury flats additional amount to be charged based on engineers estimate (about Rs. 100/- per sft extra) at the time of completion.
 - b. Developers to raise bills in 5 parts in favour of owner as follows:
 - i. 10% on plinth beam
 - ii. 30% on RCC slab
 - iii. 25% on Brick work & plastering work
 - iv. 25% Finishing works
 - v. 10% on Completion
- 7. Accountants to make an estimate for bills to be raised by Owners in favour of their customers and Developer in favour of owner based on milestone for period upto 30-05-2020. Note that plinth beam for all flats in MPL is completed and plinth beam for blocks A&B in GMR is completed. The values mentioned in point 5b & 6b to be reviewed after the rough estimate.
