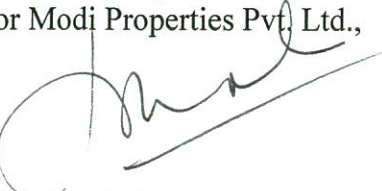

5. For all customers introduced by you brokerage at the rate of 2% on the net sale consideration shall be paid to you. 12. Modi Properties shall have right to terminate this agreement at any time without assigning any reason at its discretion.

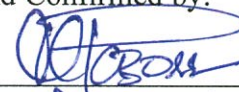
