7. Customers who have contacted us prior to intimation by you as given above, shall be deemed to be customers of Modi Properties and brokerage for such customers shall not be payable. The final decision in this matter shall be at the discretion of Modi Properties and claims shall *not be made on this count*.

13. Modi Properties shall have right to terminate this agreement at any time without assigning any reason at its discretion.

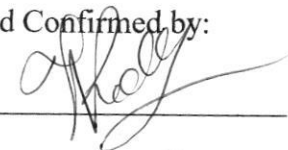
