4. Our sales team will handle the customer after your introduction of the customer to our sales team.



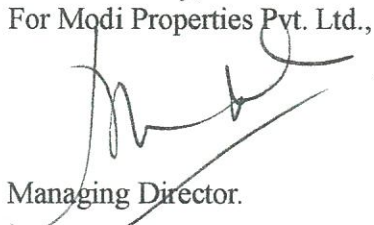
