PETITION FOR ADIMISSION OF ADDITIONAL EVIDENCE

In relation to the appeal for AY 2018-19, the appellant has submitted certain vital documents (referred below) which are very important in adjudicating the appeal on merits. The documents could not be submitted during the course of assessment proceeding for the reasons explained as under.

Firstly the documents being submitted are very old (more than 20 and 30 years old). At the point of time when assessment proceeding was going on, the appellant could not trace these documents.
