- 3. It is submitted that the Kammari Eshwaraiah was died on 17-04-2009 by leaving behind the Plaintiffs No:1to 5 herein as his legal heirs and successors of the above mentioned agriculture land. After the death of the said Kammari Eshwraiah, Plaintiffs No.1 to 5 herein are the absolutely owners and possessors of the agriculture land and jointly cultivating the agriculture land to the extent of Ac.8-05 Gts. The Death Certificate is issued by the Panchayath Secretary, Kothapally Grampanchayat Office, Shankerpalli Mandal, Ranga Reddy District.TS. Since the date of the death of the said Kammari Eshwaraiah, the Plaintiffs No:1 to 15 herein have been cultivating the agriculture land jointly in their extent of land without anybody interruption and disturbance.
- 4. It is further submitted that the Kammari Narayana was died on 09-04-2012 by leaving behind the Plaintiffs No:9 to 15 herein as his legal heirs and successors of the above mentioned agriculture land. After the death of the said Kammari Narayana, Plaintiffs No.9 to 15 herein are the absolutely owners and possessors of the agriculture land and cultivating the land jointly to the extent of Ac.8-05 Gts. The Death Certificate is issued by the Executive Officer, Kothapally Grampanchayat Office, Shankerpalli Mandal, Ranga Reddy District.TS. Vide Lr. No:14/GP/2012, dated: 9-8-2012. The Death Certificate is herewith enclosed for kind perusal and knowledge. Since the date of the death of the said Kammari Narayana, the Plaintiffs No:1 to 15 herein have been cultivating the agriculture land jointly in their extent of land without anybody interruption and disturbance.

- 5. It is further submitted that the deceased Kammari Narayana had got two wives through his wedlock i.e. Laxmamma and Yadamma. The said Laxmamma blessed three children i.e. Plaintiffs No:9, 10, and Kammari Venkataiah and the said Kammari Venkataiah S/o. Narayana died leaving behind the Plaintiffs No.11 to 15 as his legal heirs and successors and grand children of deceased Kammari Narayana.
- 6. It is further submitted that the Kammari Yadamma was died on 3-11-2016 by leaving behind the Plaintiffs No:6 to 8 herein as her legal heirs and successors of the above mentioned agriculture land. After the death of the said Kammari Yadamma, Plaintiffs No.6 to 8 herein are the absolutely owners and possessors of the agriculture land and cultivating the land jointly to the extent of Ac-8-05 Gts. The Death Certificate is issued by the Executive Officer, Kothapally Grampanchayat Office, Shankerpalli Mandal, Ranga Reddy District.TS Vide Lr. No:14/GP/2011, dated: 22-11-2016. The Death Certificate is herewith enclosed for kind perusal and knowledge. Since the date of the death of the said Kammari Narayana, the Plaintiffs No:1 to 15 herein have been cultivating the agriculture land jointly in their extent of land without anybody interruption and disturbance.
- 7. It is further submitted that the defendant No.1 & 2 are the main key persons to provocate and instigate the defendants No.3 to 38, hence the defendants No.1 to 38 unnecessarily and without any reasons and cause, the defendants No.1 to 38 herein are trying to create the nuisance and petty

destroyed by Plaintiffs herein and this Plaintiff herein many times told the defendants not to interfere into the above suit schedule agriculture land in the absence of the plaintiffs herein with the support of the anti-social elements, even after the defendants promised and assured the plaintiffs that the defendants shall not interfere into peaceful possession and enjoyment of the above said agriculture land jointly. The defendants No.1 to 38 are the totally strangers and Non-local and they do not have any valid right and title over the suit schedule property.

- 4. It is submitted that the main intention of the defendants No.1 to 38 to grab and occupy illegally by interfering into the suit schedule property in order to harass and torture in all the corners to the plaintiffs herein so that the Plaintiffs No.1 to 15 herein shall sell their extent of land to the defendants No.1 to 38 herein by making plotting systems and now the suit schedule property is a prime property and also is in prime location.
- 5. It is submitted that the defendants No.3 to 38 on the directions and provocation and instigation of the defendants No.1 & 2, the defendants are visiting the suit schedule property and disturbing the Plaintiffs and giving warning and imminent threat that If they are not sold the suit schedule property to the defendants herein they will come with more force and dispossess the plaintiffs while cultivating the suit schedule property and there is a imminent danger to the Plaintiffs from the defendants and their

associates. The defendants are not avoiding in future complications or disputes, so these defendants deliberately and Intentionally unnecessarily continuing their illegal activities and creating nuisance and trespassing into the suit schedule property from the following dates i.e. 31-1-2020 and 5-03-2020 and making efforts to grab the land illegally. The Plaintiff resisted them from interfering and advise them not to interfere into the suit schedule property. This Plaintiff are the innocent and law abiding citizen.

- 6. It is further submitted that on 29-08-2020 again the defendants along with anti-social elements came to the suit schedule property and created a panic scene with the Plaintiffs and their family members and the Plaintiffs along with their family members altogether resisted and opposed their illegal activities and all the defendants went away from the suit schedule property. It is further submitted that with the ulterior motive and wrongful notions, they want to grab the suit schedule property in order to harass and torture these Plaintiffs for their wrongful gain.
- 7. It is further submitted that finally on 2-11-2020 while so the defendants along with anti-social elements at 2-30 PM came to the suit schedule property and created the severe ghalata and nuisance and trying to interfere into the suit schedule property due to which the plaintiffs and some other persons opposed and resisted them from interfering of their illegal acts, but the defendant along with anti-social elements while going away

and occupy the suit schedule property and also warned and threatened that If the plaintiffs not to sell the suit schedule property to them only under lowest price then they will see the end of their lives and also danger. The Plaintiff immediately approached and reported the same to the concern police station and also requested to accommodate the police protection, but the police advise the plaintiff to get the some orders for the protection of suit schedule property from the clutches of the defendants. reported the same to the concerned PS, but the police advised the plaintiff to approach the appropriate court for their redressal and remedy.

- 9. It is submitted that the defendant who are not having any legitimate rights over the suit schedule property and also legally claim and interest of the same, but the unnecessarily adopting illegal methods to grab the land without any valid documents, as such since the Plaintiffs having the legitimate rights to protect the suit schedule property from all corners as a lawful owner and possessor. Approaching this court of his redressal.
- 10. It is submitted that The defendant succeeds in his illegal attempts the very purpose of filing this case will be infructuated and the plaintiff is put to suffers a great hardship and injury and his valuable legitimate rights involved in the suit schedule property will be effected very badly beyond the compensation. The Plaintiffs have established their prima facie case and balance of convenience in their favour. The plaintiffs have filed the separate Application for granting of Ad-Interim Injunction in their favour.

That the Plaintiffs have not filed any other suit or petitions before any other court of law or forum for the reliefs claimed in this suit and there is no collusion in between the Plaintiffs and defendants herein.

#### V. <u>CAUSE OF ACTION:</u>

The cause of action arose to the plaintiffs on 31-1-2020 and 05-03-2020 and 29-8-2020 when in the absence of the Piaintiffs, the defendants came to the suit schedule property and creating the nuisance, harassing, torturing, ghatlatta, trespassing and interfering into the suit schedule property and also further tried to interfere into the peaceful possession of the Plaintiffs over the suit schedule property and immediately the Plaintiffs opposed and resisted their illegal attempts and nuisance and finally on 2-11-2020 at about 2-30 PM the defendants and henchmen came to the suit schedule property and created the ghalata severe by interfering to the suit schedule property and the Plaintiff approached and reported the said incident before the concern PS and the cause of action is continuing.
