



- D. On 5 November 2007, Shriram Venture and the Vendor (then known as 'Ramky Estates and Farms Private Limited') executed an unregistered Agreement of Sale Cum General Power of Attorney, as validated on 7<sup>th</sup> December 2012 in File No.5784/AR/2012 on the file of District Registrar and Collector, Ranga Reddy District ("Agreement of Sale cum GPA"), whereby, the Vendor agreed to construct 1,00,000 (One Lakh) sq.ft. of built up area along with 45,000 (Forty Five Thousand ) sq.ft. of car parking area on the Land for Shriram Venture in consideration for a total sum of Rs. 14,00,00,000 (Rupees Fourteen Crores) paid by Shriram Venture to the Vendor, and transfer of undivided share of the Land to the extent of 12,738 sq. yds. by Shriram Venture to the Vendor.
