As per our records there was no instruction to Rasta films to take up virtual tour of other projects. Homes with an intention to extend it to other projects after seeing the output of Rasta Films. - Under the circumstances payment for virtual tours can be made as follows:
- Case 1 -- in case Rasta films has any written correspondence from Modi Properties clearly asking them to complete virtual tours of other projects, then Modi Properties will pay all outstanding bills in line with rates negotiated for Vista Homes.
- Case 2 in case there is no clear instructions to Rasta films to complete the virtual tours, then as a gesture of goodwill and in order to continue our relationship with Rasta films Modi Properties shall pay 50% of the outstanding bills in line with rates
- Since Rasta films has not maintained proper books of accounts, details of payments from the books of accounts of Modi Properties must be accepted negotiated for Vista Homes. In such a case Rasta films must certify that all accounts are deemed to be settled.
