It is also submitted that after attending his colleague, as soon as he reached this Hon'ble Commission, the ex-parte order was passed by this Hon'ble Commission. It is submitted that when he enquired about the order passed by this Hon'ble Commission from the Court Master, he was informed that ex-parte order closing the right of the Opposite Party to file the Written Statement/Reply had already been passed. It is submitted that the non-appearance in the matter was not intentional. The act of the Advocate is bona fide and due to certain unavoidable circumstances. The mentioned reason for non-appearance may be submitted on affidavit by the Advocate in case this Hon'ble Commission feels it proper.
